- ◆ Assessment Fee

Step 2. Upon acceptance to Harbor Christian Schools:

Tuition and Fees 2025-2026

Application Fee: **\$325**

The application fee is payable with application and is non-refundable. This fee includes the issuance of the I-20 for student visa.

Assessment Fee: **\$175**

This fee is required for assessment in order to determine placement.

Curriculum Fee: **\$500**

Curriculum will remain the property of the school. A fine will be assessed for lost or damaged books.

Annual Rates:

Grades K – 8	\$11,000
Grades 6 – 8	\$11,500
Grades 9 –12	\$11,950

International students are required to pay the full year's tuition and fees to finalize enrollment.

International Student Fee: **\$2,000**

This fee is in lieu of the Scrip fees, parent volunteer time, and fundraising efforts that are required of students and their families during the school year. This fee covers expenses for field trips and yearbooks.

Also, this fee will cover additional costs for professional assistance in order to ensure academic success, language skills enhancement, and cultural integration up to \$500.00.

Additional Needs:

Fees (after the first \$500) for private tutoring or special assistance outside the regular classroom instruction will be charged to parents on an individual basis. Parents will be notified in advance of the need for these fees.

Transfers:

Students who transfer to Harbor Christian Schools after the school year has started will be charged on the basis of the number of months left in the school year. All other fees still apply.

All books must be returned and all current tuition and fees must be paid before the school will authorize withdrawal or release grades and transcripts.

All tuition and fees are non-refundable.
